





Prof. Dr. Malek BajboujDirector of International Affairs, Charité

Malek Bajbouj is the Director of International Affairs at the Charité in Berlin, where he is also Professor of Psychiatry and Affective Neuroscience. Bajbouj investigates how emotions and emotional memory are represented in the human brain and influenced by environmental and cultural factors. As head of the Global Mental Health research group, he is the initiator of numerous projects in Germany, the Middle East, and the Far East in which culturally sensitive treatments for refugees are developed and institutionalized locally.

His political work concentrates a lot on large structural reforms towards digitalization in the German health system.
